## <u>Pioneer Announces Proposed Changes in Corporate Governance Structure</u> and Management

Pioneer Corporation has announced Proposed Changes in Structure and management/responsibility changes with the aim of improving corporate governance, effective June 27, 2012. Details are as follows:

#### ■ Improvement in corporate governance

In addition to the Board of Directors, which makes decisions on management policies and other matters and supervises business activities, the executive officer system has to date been adopted to expedite business activities and to clarify responsibility. Aimed at improving corporate governance, a new structure will be established to enable the directors to specialize in decision-making and supervising functions from a Group-wide perspective and the executive officers to enhance their executing functions.
